_____ This agreement covers the current relationship between Fat Cat’s Dog Boarding and yourself. Each time you bring your pet to Fat Cat’s Dog Boarding, you affirm the terms of this Agreement, and the truthfulness and accuracy of all statements you make in this Agreement.

_____ Fat Cat’s Dog Boarding reserves the right to immediately change your pet’s type of boarding if we believe it is necessary to protect the health and well-being of your pet, other pets, or our staff.

_____ Boarders must be current on all vaccinations. You will be required to provide a copy of your pet’s updated vaccination records from your vet at time of boarding or before, to ensure your pet’s safety as well as that of other boarders. Vaccines include Bivalent flu prevention, DHLPP, Rabies, Bordetella (every 6 months), Feline Leukemia.

_____ If your pet is exhibiting any symptoms that may suggest illness such as sneezing, coughing, wheezing, runny eyes or nose, vomiting, lethargy, or diarrhea, please let us know before you bring your pet for boarding.

_____ Pets with flea or tick infestation will be treated with a flea/tick product (Capstar or Frontline Plus) at the owner’s expense.

_____ The house brand of pet food is Science Diet. If you are feeding any other food, please bring it with you. Changing your pet’s food may cause severe upset stomach.

_____ Owners are welcome to bring their own bedding or toys if desired, however we cannot guarantee that they will be returned in the same condition.

____ Family members are permitted to visit our guests, can even take our canine guests for a walk or out to the play area with written consent from owners and prior arrangement with staff.

____ We accept Visa, MasterCard, Discover, American Express, cash, or check (please note, there is a \$25 returned check fee). Payment is due upon pickup of your pets.

- a. ____ You indicate your agreement with all the terms listed hereof
- b. ____ You authorize Fat Cat's Dog Boarding to obtain medical and vaccination records for your pet from the veterinarian listed above and you hereby authorize your veterinarian to provide these records to us.

- c. ____ You release, indemnify, and agree to hold Fat Cat's Dog Boarding harmless from any and all manner of damages, claims, loss, liabilities, costs or expenses, causes of actions or suits, whatsoever in law or equity, (including, without limitation, attorney's fees and related costs) arising out of or related to the services provided Fat Cat's Dog Boarding, except which may arise from the sole gross negligence or intentional and willful misconduct of Fat Cat's Dog Boarding, including, without limitation, (i) any inaccuracy in any statement made by yourself or information provided by you to Fat Cat's Dog Boarding, (ii) your pet, including but not limited to destruction of property, bites, injury, and transmission of disease, and (iii) any action by yourself which is in breach of the terms and conditions of this agreement.
- d. ____ Any controversy or claim arising out of or relating to this contract, or the breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this contract, shall be settled by arbitration in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by an arbitrator may be entered in any Court having jurisdiction thereof. The arbitrator shall, as part of his award, determine an award to the prevailing party of the costs of such arbitration and reasonable attorney's fee of the prevailing party.

I understand that Fat Cat's Dog Boarding, the owner and employees will take responsible precautions against any injury, escape, and/or death of this pet(s). Fat Cat's Dog Boarding staff will not be held liable for any problems that may develop provided that reasonable precautions and care are provided. I understand that any injury/illness of my pet while under the care of Fat Cat's Dog Boarding will be treated as deemed necessary, and I assume full responsibility for any and all treatment expenses.
